Furthermore, the committee also reserves the right to disapprove an Inductee package if sufficient information was not provided.
3. Inductee's will be honored at the Annual MFHF Annual Event, held 23 March 2024. This year's Firefighter's Awards Banquet/Ball will be held at the Pearl on the Concho Hotel, 333 Rio Concho Dr on 23 March 2024 at 6:00 p.m. The dress will be Semi-Formal.

2024 Lifetime Achievement & Hall of Fame Awards Criterion

1. The criteria for the Lifetime Achievement Award and induction into the Hall of Fame are listed below. Highlight the accomplishment(s) of the individual and the impact they had on their branch's Fire and Emergency Services section and/or on the Department of Defense, Fire and Emergency Services community. Nominators are not limited to individuals from their respective service component.
2. The overall winner of the Lifetime Achievement Award as well as the four (4) runner ups will be inducted into the MFHF Hall of Fame for a maximum of (5) inductees annually.
3. Packages will be scored by a Selection Committee panel comprised of individuals who are external to the MFHF board and its committee members.

Lifetime Achievement Award & Hall of Fame Induction:

1. Individual must have completed at least 20 years of service to Military Fire and Emergency Services (provide service dates on nominee package) or committed an act of extreme merit. If 20 years have not been met, a justified reason must be attached.
 - a. Military inductee has to be retired/separated (honorably)/discharged (honorably) for 4 or more years. If 4 years have not been met, justified reason must be attached.
 - b. Civilian inductee does not have a time frame to be retired.
2. All nominations shall be submitted in a word document in Times New Roman "12" font. Nomination shall be no more than Fifty (50) lines in either bullet or narrative format. Headings shall read:
 - a. NOMINEE INFORMATION
 - Full name to include middle initial.
 - Current address, phone number and e-mail address (if available)
 - b. ASSIGNMENTS/SERVICE DATES
 - c. CAREER ACCOMPLISHMENTS
 - d. DOD F&ES IMPACT

3. CAREER ACCOMPLISHMENTS

During his career, Chief led various departments to 2 DoD, 2 AF and 11 AFMC level awards. In 2007, he received Chief Fire Officer Designation thru the Center for Public Safety Excellence and in 2014 led EFES to its first Accredited Agency status thru the Commission on Fire Accreditation International. Most recently, Chief was praised by the AF, USMC, USCG and the LANG for his exceptional performance as Incident Commander during the response/recovery of a U.S. Army National Guard, UH-60 Blackhawk helicopter with 11 personnel on board which crashed into the Inter-Coastal waterway adjacent EAFB. Chief led 35 emergency response agencies (400 personnel) over a 10 day period, recovering all 11 crew members, the aircraft and its flight data recorder which proved crucial in determining the cause of the crash. Chief was highly commended by all service officials for his professional recovery operation briefing to multiple national media outlets as they reported the helicopter crash story “live” as breaking news across the country.

Recognized across AF FES as an innovative leader, exceptional instructor and valued mentor! Chief has been an adjunct instructor for the DoD, Louis F. Garland, Fire Academy, Goodfellow AFB and the Commander's Professional Development School, Maxwell AFB for over 14 years. He mentors students attending executive Fire Officer courses, the Fire Marshal Course, the Mortuary Officers' and Technicians Course, the AF Incident Management and Wing Commander Executive Level Response Courses. Chief has mentored over 1,000 Base Civil Engineers, Group and Wing Commanders, and executive fire officers from across the DoD. Chief was a technical advisor for the AF PPE Strategic Sourcing Initiative; he developed AF PPE technical specifications, conducted garment evaluations and made recommendation for PPE contract award which is an estimated \$80M contract. Lastly, Chief has developed an Active Shooter RTF capability which has been lauded by AFIMSC as the AF model upon enterprise-wide policy guidance/equipment requirements will be determined. .

4. DOD F&ES IMPACT

Chief petitioned the NFPA 1500, Technical Committee and OSHA to change aircraft firefighting PPE standards. After a grueling 8 year process, the NFPA/OSHA changed their PPE standards! Chief's stalwart determination to change the standards has improved the safety of 9,200 AF FF's (12,000 total DoD) by ensuring FFs utilize the appropriate PPE based on the daily risks they encounter. Additionally, the change in PPE guidance eliminates the requirement to outfit AF FF's with ProxPPE and structural PPE...this will save the AF an estimated \$25M in PPE costs over the next 5 years. Chief was instrumental in securing, preserving and presenting an O-6 Cardox aircraft firefighting vehicle to the Military FF Heritage Foundation where it sits on display along the Troop Walk for all future and present DoD FF's to reflect upon our rich firefighting heritage
